

### NOTE ON PENDING DISTRIBUTOR REGISTRATION RENEWAL CASES

# **Background:**

- 1. As per the SEBI Circular dated 2<sup>nd</sup> May'24, all PMS Distributors are required to obtain registration with APMI.
- 2. Further, the SEBI Circular dated 9<sup>th</sup> April'25, mandates that if a Distributor fails to renew their registration with APMI by 31<sup>st</sup> July'25 they shall:
  - a. Not be permitted to source new assets, and
  - b. Any commissions withheld must be refunded to the respective clients.

#### Important:

Registration with APMI remains valid up to the expiry date of the distributor's NISM Series-XXI-A certification.

## **APMI Distributor Registration Renewal Process & Timelines:**

To facilitate timely renewal, APMI follows a structured communication and tracking process:

- 1. Renewal Notification Schedule:
  - APMI initiates renewal reminders well in advance of the NISM XXI-A expiry.
- 2. First Email Notification:
  - It is sent 90 days prior to expiry, with certificate details and the link to renew APRN/EUIN.
- 3. 4 Subsequent Reminders:
  - If renewal is not completed, additional reminder emails are sent at:
    - 60 days before expiry.
    - 30 days before expiry.
    - 15 days before expiry.
    - 7 days before expiry.
- 4. Renewal Process for APRN/EUIN:
  - Distributors can renew their registration using the following steps:

      - 1. Select the 'Renewal' option
      - 2. Fill in the online form, make the applicable payment, and complete the e-sign process





#### **Next Steps:**

- If the distributor fails to renew even after the fifth reminder, the case is moved to the 'Distributor Registration Renewal Pending' category.
- To support our members, APMI has introduced a dedicated reporting utility.

#### **Distributor Registration Renewal Pending Report:**

- APMI Members can access and download the report using the following path:
  - apmiindia.org > Member Login > Menu > Reports of the Portfolio Managers > Distributor Registration Renewal Pending Report



The utility allows master filtering at Applicant Type, bifurcated into Individual & Non-Individual- post this:

# A. By Tax Status

- o All
- Employees
- Individuals
- Sole Proprietorship

#### B. By Search Criteria

- o APRN Number
- APRN/Employee/Company Name
- EUIN Number
- First select the Applicant type & then use either A or B to generate the report in a excel format.
