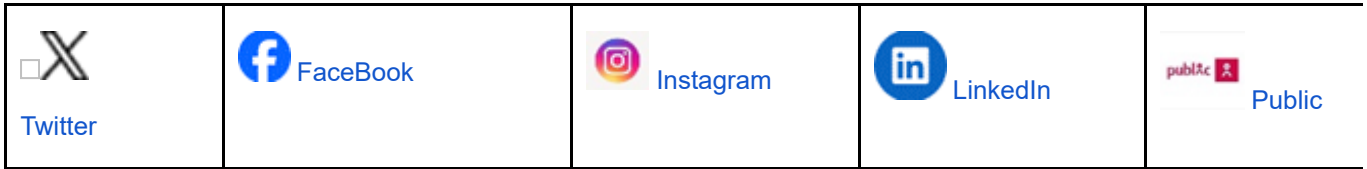

CERSAI has been designated as authority under section 9(1) of Banning of Unregulated Deposits Scheme (BUDS) Act, 2019 for the implementation of BUDS portal accessible to the public that will have information about list of deposit takers operating in India, the extent and areas of their operation. In this regard, NiyamitNivesh portal (BUDS portal) is available and can be accessed using URL <https://www.niyamitnivesh.in>.

2). The Deposit Takers regulated by nine Regulators namely RBI, SEBI, IRDAI, PFRDA, MCA, EPFO, NHB, State Government or Union Territory Government and Central Registrar, Multi State Co-operative Societies have to onboard on this Registry.
