• Old Criteria and thresholds for Portfolio Managers Categorization:

Revised Criteria and thresholds for Portfolio Managers Categorization:

1	AUM	NA	Above Rs. 10,000 Crores	Above Rs. 3,000 Crores and below Rs. 10,000 Crores	Rs. 3,000 Crores and below

Please note:

- 1. The necessary amendments to the SEBI Circular on the Cyber Security and Cyber Resilience Framework (CSCRF) will be carried out in due course.
- 2. Please note that the revised threshold categorization does not impact the submission timelines in any way.
- 3. This revision is limited to the reclassification of Mid-size REs and the inclusion of Small-size REs.
- 4. All other provisions of the CSCRF Circular remain unchanged.
