This has reference to roll out of SCORES 2.0 on April 01, 2024. For the purpose of providing SCORES authentication to the registered intermediaries ('entities'), the concerned department has raised certain issues, based on which the following information is being sought.

The concerned department in SEBI has requested that for each registration, unique email address may be provided. For example, in case of two or more entities of the group are registered in any capacity with SEBI, so for the purpose of authentication in SCORES 2.0, separate



email addresses are required for each registered entity. Kindly note that it may be specified to the PMS to provide email address which can be monitored actively as all future communication wrt SCORES 2.0 shall be received on the same.

(A) Portfolio Managers for whom email address is not available.

(B) Portfolio Managers (same group entities) having same email address.

APMI is requested to handle this project on priority and provide the requisite information by Monday.
